Code of Conduct

1. Every member of the choir must faithfully attend rehearsals and all scheduled performances. Exceptions include illness or absence due to an unforeseen circumstance.
2. Choir members must be punctual to rehearsals and performances.
3. Self discipline must be practiced during rehearsals and performances. Poor behavior hinders the positive experience of the choir for others.
4. Choir members are to give their full attention to the director or anyone addressing the choir.
5. Choir members are to treat one another and adults kindly and with respect.
6. Choir members are to enthusiastically participate in rehearsals and performances.

Formal Attire (Choir Only):

- white button-down (oxford-type) long-sleeve shirt for boys
- white long-sleeve blouse for girls (please no shiny material or large ruffles)
- black, dress slacks for boys / black, mid-calf length skirt and tights or dress slacks for girls
- black shoes

Informal Attire (Choir Only):

- our signature t-shirts (one is included with tuition)
- nice denim jeans/skirt (mid-calf length)
- nice closed-toe shoes (no boots)

Standards for Performance Attire (Choir Only)

(The following applies before, during and after performances.)

1. Do not alter or change the formal attire in any way (i.e. un-tucked shirt, unbuttoning shirt to wear as a jacket, etc.).
2. T-shirts (for casual performances) are NOT to be altered in any way (i.e. rolling sleeves, tying up shirt at hip).
3. T-shirts may be tucked or un-tucked.

Dance Attire

Black or pink leotard, tights, ballet shoes for class plus additional performance attire.
